It has been the practice so grant recognition to schools for a limited period and scuh recognition used to lapse on the expiry of that period unless such recognition was renewed before the expiry of the period. This practice was based on rule 54(2) of the Delhi School Education Rules 1973. In civil writ No.883 of 1977 in the case of Digambar Jain Society, the Hentble Righ Court of Delhi delivered a judgment in 30-8-1979 holding rule 54(2) ultra vires of the Delhi School Education Act, 1973. The operational portion of the said judgment reads here as unders

provisions of the Act and Rules, I am of the epinion that Rule 54(2) is ultra vires of the Act, and that recognition orginally granted to the school was an absolute recognition at any rate, the recognition granted after 31-12-73 must be treated as the absolute grant of recognition within the scope of Rule 54. It must be deemed that the authority was satisfied that of some time the school will be able to fulfil the requirements and condition for grant of recognition and because of this satisfaction a provisional exemption was given to it and the school was recognised. This being so, the recognition and because of this satisfaction a provisional exemption was given to it and the xeks school was recognised. This being so, the recognition cannot be taken as any from the school exception the manner centemplated by Section 4 Sub-Section (4) or (6)\*.

The Prescribed Authority (Administrator of Delhi-Lt. Governor) announced his judgement on 9-11-79 in the case of Appeal Hollas/79-C.A. in the case of Bahar Education Trust Vs. State as here under:

"In view of the law laid down by the Delhi Righ Court
in the case of Digambar Jain Society, it has been held,
and I hold accordingly that the appellent school continued to be recognised school. In case the Director of
Educations of the opinion that the school does not
satisfy any one of the condition specified under sub-section
(1) of Section 4, he will have to follow the procedure
laid down under section (6) of section (4) read with rule
56."

In view of the above cited High Court Judgement and above quoted Pronouncement of the Prescribed Authority (Lt.Covernor), recognition of no school shall lapse as specified under rule 54(2). Recognition once granted shall be absolute.

Hence no school will be deemed recognised for a limited period, no matter whether it was recognised prior to the commencement of the Act/Rules, 1978 or has been granted recognition thereafter. Hence forth all recognised schools shall be deemed to be permanently recognised and recognition could be withdrawn only through the procedure laid down under sub-sec.(6) of Section (4) of the Act read with Rule 56 of Delhi, School Education Rules, 1978.
